Measure U covers Elementary and Middle School Sites, including Branciforte Small Schools. Some teachers split their time at different sites. Discussion ensued regarding the positive impact of counselors at Elementary and Middle School Sites.

Discussion continued regarding the potential approval of Proposition 28 Arts Funding from election in November.
