Approval of Minutes

Measures T

Assistant Superintendent Jim Monreal presented Unaudited Actuals for Measure T, which funds grades 9-12. The report provided the full amount of salaries including health benefits and strs/pers benefits covered by parcel tax dollars.

Discussion ensued over how the STRS/PERS column is reported. A suggestion was made to remove the STRS/PERS column and include total compensation in one column.

Measure U

Assistant Superintendent Jim Monreal presented Unaudited Actuals for Measure U, which funds grades K-8. The report provided the full amount of salaries including health benefits and STRS/PERS benefits covered by parcel tax dollars.

Discussion ensued about Proposition 28 funding and how each school site's funds will be allocated.

Measure O

The Committee Members were informed that Measure O 2021-22 Unaudited Actuals are included in the respective Measures T & U as a line item for the remaining carryover dollars.

Discussion ensued over carryover dollar amounts and how each site utilizes the funds. A suggestion was made to present a year-end report detailing how the carryover dollars are spent, specifically across Soquel High, Harbor High, and Santa Cruz High.

Career Technical Education (CTE)

Assistant Superintendent Jim Monreal updated the committee members about the District's Career Technical Education (CTE) program offerings, with hopes of creating a similar CTE program at Mission Hill Middle School and Branciforte Middle School.

Discussion ensued over the benefits of CTE classes, how the program prepares all kids for their futures, and the success rates for students who partake in CTE classes.
